**1. Item No. 1: Review of earlier NAAC meeting**

Principal welcome to IQAC members. IQAC Coordinator presented the action taken report of earlier IQAC meeting.

**2. Item No. 2: Plan of Action for Academic Year 2021-22**

IQAC Chairperson and IQAC Coordinator presented the following plan of action for next academic year (i.e. 2020-21).

- 2.1. To update material developed for online teaching
  - 2.2. To motivate faculty members to participate in online FDPs, Workshop, etc.

  - 2.5. To strengthen Training and Placement related activities
  - 2.6. To conduct Department Audit
- It was discussed and approved.

**3. Item No. 3: Plan for Implementing the academics in online mode**

Principal and IQAC Chairperson has elaborated that the plan for online teaching plan of last year was implemented successfully and the same will implemented for academic year 2021-22.

**4. Item No. 4: Revised Documentation Templates**

IQAC Coordinator presented the revised documentation templates for organized and participated events. It is approved for implementation from academic year 2021-22.

**5. Item No. 5: Presentation on Revised system for Slow and Fast Learners**

Prof. Milind Kirkire, Dean Academics has presented the draft of revised system for

identification of slow and fast learners and efforts taken on them.
